You may be eligible to receive an 8% rebate on your electricity bill effective January 1, 2017 under the *Ontario Rebate for Electricity Consumers Act, 2016*. If your account meets any of the eligibility criteria below, please check off all boxes that apply, and sign and date the form. Once completed, please return to GSU as per the instructions above.

If you qualify for the rebate, we will retroactively credit your account for consumption effective on or after January 1, 2017 or to a maximum of two years from the date you provided us with the completed self-declaration form, if submitted after January 1, 2019.

### Eligibility for the 8% rebate

To be eligible to receive the 8% rebate on your electricity bill, you must qualify under at least ONE of the following criteria:

(Please check all that apply to your account)

- a property, within the meaning of the *Condominium Act, 1998*,
- a residential complex, within the meaning of subsection 2 (1) of the *Residential Tenancies Act, 2006*, without regard to section 5 of that Act, or
- a property that includes one or more housing units and that is owned or leased by a co-operative within the meaning of the *Co-operative Corporations Act*.
