Regulated Price Plan (RPP):

Multi-Unit Residential customers who own a building that has multiple residences, but only one meter and buy their electricity from Greater Sudbury Hydro (GSH) may declare this information to qualify for the RPP tiered pricing rates for residential units.

Step One – Does your account qualify?

Your account qualifies if your property falls into one of the following categories:

- a dwelling; a property as defined in the *Condominium Act, 1998*; a residential complex as defined in the *Residential Tenancies Act, 2006*; or a property that includes one or more dwellings and that is owned or leased by a co-operative as defined in the *Co-operative Corporations Act*.

Step Two – Complete the form:

If your account qualifies, please fill in the information below. You must advise us in writing if your account ceases to qualify or if there is a change in the number of units within the property or complex. I, we acknowledge that, if it is determined that the account for which this declaration applies was not eligible, that I, we named on this self-declaration may be responsible to repay amounts received as well as to cover GSH's losses regarding same, to the extent that such losses result from information provided on this self-declaration.

All information submitted in this process will be used by GSH in support of its obligations under the Electricity Act, 1998, the Ontario Energy Board Act, 1998, applicable Ontario Energy Board Codes and Rules, associated policies, standards and procedures and Greater Sudbury Hydro's license. GSH will use the information to confirm your eligibility for RPP and for auditing purposes. This information will be retained by GSH and may be subject to review by the Minister of Finance pursuant to the Ontario Energy Board Act, 1998.
