SUMMER STUDENT EMPLOYMENT

Greater Sudbury Utilities will be accepting applications for summer student employment from Thursday, December 12, 2019 to Friday, February 21, 2020.

Students who are enrolled full-time in a post-secondary institution during the academic year, or who have completed their last year of secondary school education with the spring term and intend to return to school at the end of their period of summer employment, are eligible to apply. College and University students will receive preference for employment.

Students who were employed by Greater Sudbury Utilities during the summer of 2019 and are eligible for re-hire must complete an application form to be considered for employment during the summer of 2020.
